Membership

5. Administration advised that the Seniors representative, Morgan Gebauer resigned since the last meeting. City Clerk carried out a recruiting process and Daryl Dolynny, Avens CEO, was appointed as the new Seniors representative. Administration further noted that terms of office for representatives from an organization serving Persons with Disabilities, Youth and Yellowknife Business, are expiring on February 27, 2019 and the Homelessness Partnering Strategy (HPS) Funding is expiring on March 31, 2019. Up until now it is unclear if the HPS funding will be renewed with the City. In response to a question from Administration, the three expiring membership representatives agreed on extending their term for another month Administration noted that the decision will be taken to Council for a motion.

Action: Administration to send updated Membership list to members.

Reaching Home Funding Update

6. Administration noted that H. Ferris attended the Reaching Home Funding Forum last week in Ottawa where the new funding was discussed as well as parameters around Reaching Home. The Territorial Stream is still being worked on. At this point the funding agreement hasn't been settled. More information is expected in the next few weeks.

PiT Count Report

- 8. Administration noted that according to the Federal Government funding criteria to perform a PiT Count in Yellowknife, the final report would have to be filed by September 2018. Due to lack of quorum, the PiT Count Report was not adopted by CAB members before being adopted by Council last year.

Round Table

- 9. R. Lau-a informed members about the Canada Mortgage and Housing Corporation (CMHC) Co-investment Fund. There is \$60M available in the Northwest Territories with the Federal Government able to contribute up to 75% of the cost. R. Lau-a further relayed that capital dollars are available under this fund for programs with an ongoing sustainability plan such as Permanent Supportive Housing. There is funding available for seed applications and organizations should contact him for more information if interested in applying.
 - D. Dolynny noted that there is going to be two large scale projects happening in Avens. The first one is the kitchen and laundry expansion and the second one is a complete revitalization of the housing continuum in terms of affordable housing.
 - I. Notley noted that Hope's Haven have currently ten units in five different buildings that accommodate 21 participants including five families and 13 single youths. I. Notley further noted that having units in five different buildings is resource and financially limiting, therefore Hope's Haven have been in negotiation with Northview to assume a building with twelve units as of April 1, 2019. I. Notley further noted that as of March 31, 2019 Hope's Haven was not able to secure financial support to carry on with the program.
 - W. Haley noted that she participated in the On Land Funding application review last week, since she is responsible for donations and sponsorship at Diavik. It was further noted that some of the applications targeted some of the homeless programs in Yellowknife.

The Chair, S. Smith noted the importance of attendance of members. S. Smith further noted the stand in role and the consequences of being absent for two consecutive meetings.

B. Denning noted that the Housing First program is currently housing seventeen individuals with an additional three moving in shortly and two people that are considered



to be "un-house able" and two other participants that were considered to be 'un-active" and that two women attended the healing camp in Fort Smith last week.

R. Tambour-Zoe noted that the Native Women's Centre has started a Poverty Program to help those who are still in need and that their organization is having regular meetings to discuss their issues.

E. Shea noted that the Northwest Territories Housing Corporation (NWTHC) hired Northway's Consulting to review the Government Northwest Territories (GNWT) Homelessness Resources throughout the territory. E. Shea further noted that an advisory committee will be put together to consult. E. Shea further noted that the NWTHC is working on thirty-three community plans throughout the territory. They are expecting to work with six communities in the first year. E. Shea further noted that there are three Supportive Housing Projects being built in the NWT in Fort Simpson, Aklavik and Behchoko. NWTHC is also looking at expanding rapid rehousing into Inuvik.
