#### **Business Arising from the Minutes**

6. Administration provided an update on the organizations contacted to date for the 2020 Point in Time Count.

Administration noted that the Reaching Home Community Plan (the "Community Plan") will be put forth to City Council in February.

#### Discussion of Projects for 2020-2024

- 7. Administration discussed financial planning with Committee. This included a review of the Reaching Home directives, the City's 10 Year Plan To End Homelessness and the 2019-2020 Community Plan, together with recommendations to provide a starting point for Committee to consider which projects to fund.
- 8. Administration provided an update on the following projects:

Prevention and Rapid Rehousing: \$180,000.00 allocated; has helped 25 adults this year.

Housing First for Families: \$180,000.00 allocated; has helped 29 families this year.

Housing First: \$306,000.00 allocated; has helped 25 individuals this year.

9. Committee discussed the following priorities: the Coordinated Access directive, the Investment Plan component of the Community Plan, as well as a potential standardized process and procedure to guide deliberations such as a risk matrix assessment / evaluation



of directives met and an assigned point system. The idea of moving up the timeline and deadlines for funding going forward was also discussed.

Due to time constraint, the deliberation on projects for funding consideration was deferred until the following Community Advisory Board on Homelessness Committee Meeting.

Action Item: Administration will provide Committee members with the Q3 Activity Reports from the current funded programs and a document summarizing the current programs, funding and outcomes.

Action Item: Committee members will reach out to their sectors and community organizations for assistance in determining priorities for addressing homelessness. With this information, Committee will identify which projects / programs should be considered for funding under Reaching Home.
