Call to Order & Introductions

1. The meeting was called to order at 9:04 a.m. It was recognized that we are on Chief Drygeese Territory, home of the Yellowknives Dene.



Approval of Agenda

Membership Update

5. Administration provided an update to Committee on the reappointments of H. Dumbuya-Sesay as representative from an organization serving Youth and D. McKee as representative from an organization serving Persons with Disabilities, whose terms now expire on April 14, 2022, and on the advertisements posted for remaining vacancies.

Action Item: Committee is to contact Administration with suggestions to fill the vacancies for a representative from an Aboriginal Organization and from a Yellowknife Business.

<u>Discussion on Reaching Home Additional Funding Options</u>

- 6. Administration provided an update regarding requests and options for the additional Reaching Home COVID-19 funding. This included a review of service providers and their identified Personal Protective Equipment ("PPE") needs and projected costs. It was noted that at the time these requests and options were compiled, the Northwest Territories Health and Social Services Authority informed Administration they would not be able to provide PPE aid to Non-Governmental Organizations ("NGOs").
 - J. Saturnino clarified that the GNWT is now looking into PPE aid. Committee also heard that the Federal Government has since allocated money for PPE to the GNWT.

Action Item: Administration will follow up with the contact provided by J. Saturnino regarding PPE aid.

7. Administration presented options for the additional Reaching Home COVID-19 funding which included sheltering alternatives. Committee discussed properties to be explored and related recommendations from the Canada Mortgage and Housing Corporation, as well as potentially increasing the funding for the Housing First Program.

Action Item: Committee is to bring suggestions of other sheltering alternatives for Federal Government consideration to the next meeting, and Administration will forward them following discussion.

- 12. Committee explored temporary shelter / sobering center options, noting the Yellowknife Community Arena would be most conducive to physical distancing.

That Committee direct Administration to send out a letter of interest to NGOs and service providers to secure an operator for a day shelter / sobering center at the Yellowknife Community Arena the week of April 27, 2020 using Reaching Home funding, if no option from the GNWT is provided prior.

Request from Déline

13. Administration referenced a consulting firm in Dél₂ne working with the community, noting they have inquired how to access the Reaching Home funding increase that Committee is receiving from the Federal Government. Administration also noted the guidelines for the funding increase allow for utilization outside of municipal boundaries.

Committee discussed the City's limitations as a municipality and Déline's ability to work with the Federal Government directly on their request under a government-to-government relationship.

Action Item: Administration is to direct the consulting firm in Dél_lne to reach out to K. Hansen with the Federal Government directly on this issue.

Coordinated Access Discussion with Wally Czech

- 14. W. Czech with the Canadian Alliance to end Homelessness ("CAEH") joined the meeting at 10:16 a.m. and presented a proposal for assessment of Yellowknife's Coordinated Access System, detailing the technical support, consultations, review and reporting that would take place. Committee asked for clarification regarding costs factors for points of access and the scorecards to be compiled.

 - B. Denning seconded,

That Committee direct Administration to enter into an agreement with the Canadian Alliance to end Homelessness and W. Czech for the CAEH Training and Technical Assistance Program's Coordinated Access System Assessment, for the timelines noted in the Proposal and up to the estimated cost of \$6,090.
