#### Insulation Standards for Existing Buildings

Contractors, Builders and Property Owners: If you are planning projects involving insulation for additions, renovations or upgrades to existing buildings, please be advised that the Minimum Insulation Value (Section 6.7) requirements in Building By-law No. 4469 has been deferred until January 1, 2010 pending a review of the Section 6.7 by a working group. The amending By-law No. 4486 became effective May 26, 2010.

In the interim, Contractors, Builders and Property Owners should continue to use the Insulation Standards established by the Building Inspection Division, Bulletin #4 dated February 1, 1996 for insulation for additions, renovations or upgrades to existing buildings.

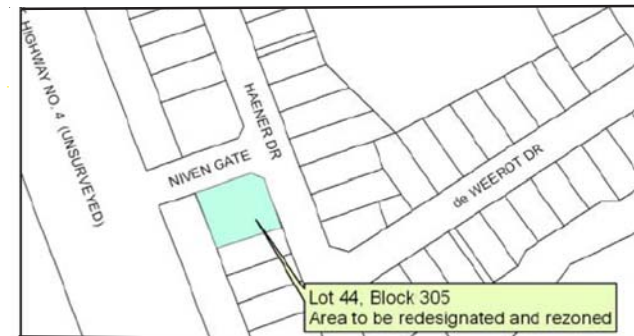

### PUBLIC NOTICE

#### By-law Nos. 4481 and 4482

The City of Yellowknife has given First Reading to By-law Nos. 4481 and 4482, by-laws to amend By-law No. 4439, as amended (Niven Lake Development Scheme 2004) and Zoning By-law No. 4024, respectively.

By-law No. 4481 amends the designation of Lot 44, Block 305, Plan 4019 in the 2004 Niven Lake Development Scheme from "C" - Commercial to "LD" - Low Density. By-law No. 4482 amends the zoning of the same lot from "SS3" - Site Specific Zone #3 to "R6" - Residential Limited - Manufacture Dwelling. These amendments facilitate the further development of the Niven Lake residential subdivision. The map below indicates the property to which the by-laws apply.
