CITY OF YELLOWKNIFE BY-LAW NO. 4701

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, authorizing the Municipal Corporation of the City of Yellowknife to amend City of Yellowknife Zoning By-law No. 4404, as amended.

PURSUANT TO:

- a) Section 25 to 29 inclusive of the *Planning Act*, R.S.N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted Zoning By-law No. 4404, as amended;

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend Zoning By-law No. 4404, as amended;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

- 1. That By-law No. 4404, as amended of the Municipal Corporation of the City of Yellowknife, is hereby amended by:
 - A) Rezoning Lot 4, Block 501, Plan 2092 from PS Public Service to R3 Residential Medium Density as shown in orange on Schedule A attached hereto and forming part of this by-law;
 - B) Rezoning a portion of Lot 8, Block 501, Plan 4426 from R5 - Residential - Manufactured Dwelling R3 -Residential - Medium Density at a maximum density

- of 67.5 units per hectare (128 units in total in the developable areas excluding roads), as shown in orange and labelled as R3.DU68 on Schedule A attached hereto and forming part of this by-law;
- C) Rezoning a portion of Lot 8, Block 501, Plan 4426 from R5 Residential Manufactured Dwelling to R3 Residential Medium Density at a maximum density of 55 units per hectare (60 units in total on the parcel), as shown in orange and labelled as R3.DU55 on Schedule A attached hereto and forming part of this by-law;
- D) Rezoning portions of Lot 5, Block 203 and a portion of ROAD, PLAN 2144 from R5 Residential Manufactured Dwelling and PS Public Service to PR Parks and Recreation as shown in green on Schedule A attached hereto and forming part of this by-law; and
- E) Amending Schedule No. 1 to Zoning By-law No. 4404, as amended, in accordance with Schedule A attached hereto and forming part of this by-law.

EFFECT

2. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the Cities, Towns and Villages Act.
