

## **BY-LAW NO. 4739**

**BZ 309** 

A by-law of the Council of the Municipal Corporation of the City of Yellowknife authorizing the Municipal Corporation of the City of Yellowknife to amend Zoning By-law No. 4404, as amended.

## **PURSUANT TO:**

- a) Section 25 to 29 inclusive of the *Planning Act*, R.S.N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law, and due opportunity for objections thereto to be heard, considered, and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted Zoning By-law No. 4404, as amended;

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend Zoning By-law No. 4404, as amended;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

## **APPLICATION**

- 1. That Zoning By-law No. 4404, as amended, of the Municipal Corporation of the City of Yellowknife, is hereby amended by:
  - A. Rezoning a portion of Lot 8, Block 501, Plan 4426 from R3 Residential Medium Density to R5 Residential Manufactured Dwelling as shown as "LD" and in orange on Schedule A attached hereto and forming part of this by-law.
  - B. Rezoning a portion of Road, Plan 2144 from PR Parks and Recreation to R5 Residential Manufactured Dwelling and PR- Parks and Recreation as shown as "LD" and in orange (R5 Residential Manufactured Dwelling) and "PR" and in green (PR- Parks and Recreation) on Schedule A attached hereto and forming part of this by-law.

- C. Rezoning portions of Lot 8, Block 501, Plan 4426 from R5 Residential Manufactured Dwelling to PR Parks and Recreation as shown as "PR" and in green (PR- Parks and Recreation) on Schedule A attached hereto and forming part of this by-law.
- D. Amending Schedule No. 1 to Zoning By-law No. 4404, as amended, in accordance with Schedule A attached hereto and forming part of this by-law.

## **EFFECT**

2. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.


