APPLICATION

1. By-law No. 4250, the Council Procedures By-law, is hereby amended by deleting Schedule D and replacing therewith Schedule D attached hereto and forming part of this by-law.

EFFECT

2. That this by-law shall come into effect as of January 1, 2008 and upon receiving Third Reading and otherwise meeting the requirements of Section 75 of the Cities, Towns and Villages Act.


