Call to Order

1. The Chair called the meeting to order at 12: 03 p.m.

<u>Heritage Committee Funding Application – Yellowknife Artists Cooperative Ltd.</u>

5. Committee heard a presentation from Mr. Matthew Grogono and Mr. Scott Lough, representatives of the Yellowknife Artists Cooperative (YAC), regarding a Feasibility Study to convert the historical Hudson Bay Warehouse, located at 3501 Wylie Road, into a Centre for the Arts. The feasibility study will determine the cost of restoring the building, identify methods to raise funds, and provide practical ways to make the building sustainable. The eventual goal would be to create a space for artists of all genres to come together to practice their craft and collaborate to enhance the art community in Yellowknife. The preservation of the building along with the nurturing and development of the arts community would contribute to the objectives of the Yellowknife Artists Cooperative.

The Yellowknife Artists Cooperative is requesting funding in the amount of \$3,000.00, which will be put toward their budget of \$16,000.00 to fund the costs of the Feasibility Study. This will include hiring a feasibility consultant that specializes in cooperative corporations. Asbestos and mildew have been discovered in the building, and a great deal of work would be required to restore the integrity of the space. The cost of alleviating these issues would be researched in the feasibility study.

As the Yellowknife Artists Cooperative is a for profit corporation, this may affect the City of Yellowknife's ability to provide funding for this project. Administration advised that they will provide policy clarification on whether the for-profit status affects funding eligibility. YAC advised that they felt it was appropriate to request Heritage Committee funding since the Hudson Bay Warehouse property is a designated heritage site.

Action: Heritage Committee will deliberate on the Yellowknife Artists Cooperative funding application for \$3,000.00 for a Feasibility Study to convert the Hudson Bay Warehouse property into a Centre for the Arts in Yellowknife. Any follow up questions from the Committee will be brought to the applicant by Administration.

<u>Heritage Committee Funding Application – Videos of our Elders Project</u>

6. Committee heard a presentation from Ms. Ann Lynagh, regarding a funding request to develop a pilot project to create videos to tell the stories of local elders and preserve the history of Yellowknife. This proposal involves videotaping elders in Yellowknife to capture their unique stories about Yellowknife's past for their family, friends and the community. The goal of this project is to create a video archive that can be accessed readily, which captures the personal history of local elders, thereby preserving their stories and creating an audio visual history of Yellowknife.

Funding is requested in the amount of \$2,000.00 for the Videos of our Elders Project which would go towards the cost of hiring a camera operator, equipment and for editing the final product. This funding request would go toward the initial videotaping of two or three people in the community as they tell their stories. If the project is successful, it could continue to grow and evolve to include a video archive of multiple elders, including pioneers of Yellowknife as well as Indigenous peoples who have lived in the area for many years. These videos would be made available to the City of Yellowknife as an archived history which would be publically available and could be used for promotions and festivals. Each video would be individually produced and could be available on YouTube.

Action: Heritage Committee will deliberate on the funding application from Ms. Ann Lynagh for \$2,000.00 for the Videos of our Elders Project to create a video archive of the stories of Elders in Yellowknife. Any follow up questions from the Committee will be brought to the applicant by Administration.

<u>Update on Use of Heritage Reserve for Repainting of Bristol Freighter</u>

13. As part of the 2018 budget, Council has approved the spending of \$55,000.00 from the Heritage Reserve to fund the repainting of the Bristol Freighter.

The original purpose of the Heritage Reserve was for the restoration of the Hudson Bay Warehouse building. This should be taken into consideration when making recommendations on spending money that is in the reserve.
