5. Chair Bussey and Mr. Marchiori have been in contact with the advocate for parental visitation rights but have not yet found a mutually agreeable date to meet.

Presentation by Capt. Ruth Gillingham, Salvation Army (12:00 p.m.)

6. Capt. Gillingham described the programs and services offered by the Salvation Army. She emphasized that her organization offers, not only short-term help to people in need, but also long-term help to make positive lifestyle changes leading to independence and full participation in the community.

Presentation by Lyda Fuller, YWCA (12:30 p.m.)

7. Ms. Fuller described the programs and services offered by the YWCA in Yellowknife. She said her clientele, mostly women and their young children, are struggling to deal with issues such as family violence, lack of affordable housing and poor economic opportunities for women.
