Describe the requested amendment, and the rationale for the request, in detail:

The Yellowknife Racquet Club (the Applicant) wishes to rezone Lots 1, 2U, 3, and 4, Block 157, Plan 1385 at 4002 49 Ave in the City of Yellowknife. The Applicant proposes to amend the zoning of the noted Lots from PR - Parks and Recreation to OT - Old Town Mixed-Use as noted in the City of Yellowknife Zoning Bylaw No. 5045. The current land use is commercial recreation, hosting a multi-functional commercial recreational facility. Rezoning would create more flexibility by expanding the number of permitted uses allowed under the OT - Old Town Mixed Use zone, increasing opportunities for potential future development on the identified sites.

A planning justification report is included to provide details on the requested amendment and rationale.
