
GROW Yellowknife Food and Agriculture Strategy



GROW- Yellowknife Food and Ag Strategy

- Is a long range strategy that sets a policy foundation for community and commercial food and agriculture activities.
- Focuses on the role of the City
- Is connected to many other plans and strategies currently or imminently in development.







Research & Engagement Process to Date

1.	Community creates the Yellowknife Food Charter	2015
2.	City of Yellowknife endorses the Food Charter	2015
3.	Yellowknife Food and Agriculture Strategy process is initiated	Sept 2018
4.	One-on-one interviews with key stakeholders are conducted	Oct-Dec 2018
5.	Stakeholder workshops on key issues and opportunities	Oct 2018
6.	Staff workshop on overall approaches for the strategy	Oct 2018
7.	Placespeak is used to identify food assets in Yellowknife	Nov-Dec 2018
8.	Opportunities Analysis is finalized and posted online	Feb 2019
9.	GROW Version 1.0 is produced	Feb 18, 2019
10.	Staff workshop on Version 1.0	Feb 26, 2019

Project Vision

A just and sustainable food system in Yellowknife is rooted in a healthy community, where everyone has access to adequate and affordable nutritious food; more food is grown and harvested locally; and food production policies and infrastructure are in place to support an economically viable, diverse, and ecologically sustainable local food system.







Goal 1: Support the sustainable growth of urban agriculture and related activities.

- Objective 1.1 Define and integrate urban agriculture into Yellowknife land use policies and bylaws.
- Objective 1.2 Support sustainable growth of small livestock and bees in Yellowknife.
- Objective 1.3: Increase opportunities for enterprise greenhouses and enclosed growing systems.

Community Feedback on the Draft

- 1. Overall support.
- 2. Acknowledge arsenic.
- 3. Water subsidy is crucial for farm viability.
- 4. Limit pesticides in Yellowknife.
- 5. View Yellowknife as a centre for food and agriculture activities
- 6. Health regulations are a hurdle.
- 7. There is a critical role for GNWT in supporting the strategy
- 8. Lack of connection to Indigenous community.
- 9. There are mixed perspectives on how to regulate urban livestock.
- 10.Make it simple.
- 11. Policy is slow, what can we do today?

Response to Community Feedback

- 46 people attended, 20 provided detailed written feedback.
- 23 Changes to the Draft were made (Please refer to engagement summary)
- New explanatory content
- New and revised objectives, actions, and implementation considerations including:
 - FAQs- what can we do now?
 - Considerations for food and agriculture in community grants
 - Advocate for water subsidy for commercial operations
 - Address arsenic testing through Giant Mines Health Effect Monitoring program
 - Use by products from fishing industry for soil amendments
 - Many others.



Impact Implementation

- Create a food and agriculture coordinator position.
- Integrate GROW into City plans and strategies:
 - Community Plan
 - Bylaws (multiple)
 - Wayfinding strategy
 - Downtown revitalization strategy
 - Economic development
 - Others.
- Working collaboratively with other sectors to achieve common goals.
- Pursuing funding to resource implementation.
