IMPACTED CITY SERVICE LEVELS

The City of Yellowknife would like to advise residents that due to the ongoing labour disruption, there are some impacted programs and services.

City Hall

City Hall will be accessible by appointment only for specific services. Residents are asked to visit the [Virtual City Hall](#) for all services available there (like paying tickets and utility bills). Responses to phone and email inquiries will be delayed.

Please visit our Virtual City Hall for the following services:

- Utility payments (can also be paid via mail, drop-box or at your bank);
- Tax Payments (can also be paid via mail, drop-box or at your bank);
- Municipal Enforcement Division tickets.

Yellowknife Public Library

The Yellowknife Public Library is closed. Online Library services will be continued. In-person programs will be paused for the time being.

Residents are asked to not return books at this time, there will be no late fees or charges applied for the duration of the closure.

Solid Waste Facility

The Solid Waste Facility is closed until further notice.

Until further notice honey bucket bin drop-off at the Solid Waste Facility will not be available to the public. The City will notify the public as soon as this service is restored.

Ruth Inch Memorial Pool

The facility is closed to the public. Swimming Lessons are suspended until further notice. Winter lessons may resume depending on the length of the labour disruption. Refunds will be issued when staff return. Make up classes will not be scheduled.

Multiplex

The Multiplex is closed until further notice.

Fieldhouse

The Fieldhouse is closed until further notice.

Yellowknife Community Arena

The Yellowknife Community Arena is closed until further notice.

Visitor Information Centre

The Visitor Information Centre is closed until further notice.

Somba K'e Bathrooms

The washroom facilities at Somba K'e Park are closed until further notice.

Outdoor Facilities Ice Rinks and Trails/Playgrounds/Sliding Hill

Outdoor skating rinks, walking trails and other outdoor facilities will not be maintained until further notice.

IMPACTED CITY SERVICE LEVELS (CONTINUED)

Waste Disposal

Garbage disposal will change to a weekly pickup schedule, and compost bins will not be collected until further notice. Blue Bin Recycling Stations will not be available until further notice.

The Solid Waste Facility is closed.

Broken garbage carts will not be replaced at this time.

Water Delivery and Sewage Pickup

These services will continue on its regular basis.

Snow Removal

Non-essential snow and ice clearing activity is suspended.

Transit and YATS

Yellowknife Transit and YATS buses will not be impacted. Passes can be purchased in the following locations:

- Direct Charge Co-op;
- Downtown Reddi Mart;
- Sutherland's Drugs; and
- Village Reddi-Mart.

For YATS passes, please call the City at 867-920-5600.

Programs and Swimming Lessons

All winter programs and lessons will be suspended until further notice. Winter programming and lessons may resume depending on the length of the labour disruption. The City will issue a refund for the affected programs when staff return to work. Make up classes will not be scheduled.

Already purchased Flexi-Passes will be extended to account for missed time periods.

Public Safety

The City assures residents there will be no impact to public safety services. Please continue to call 9-1-1 or 867-873-2222 for public safety emergencies, do not use these lines to contact City staff as residents in emergency situations need to ensure they have an open channel to connect with first responders.

Development Appeal Board

The public is hereby advised that a hearing of the Development Appeal Board of the City of Yellowknife has been scheduled for **Tuesday, March 14, 2023 at 7:00 p.m.** in the City Hall Council Chamber. The purpose of this hearing is to consider an Appeal of the decision of the City Development Officer to issue a Development Permit #PL-2023-0001 for a Multi-Unit Dwelling Fourplex on Lot 17, Block 309, Plan 4204 (130 Moyle Drive).

The Accessibility Advisory Committee provides advice to the municipal council on identifying, preventing and eliminating barriers to people with disabilities in municipal programs, services, initiatives and facilities. The committee plays a pivotal role in helping the City of Yellowknife to become an accessible community.

Seven members of the advisory committee must be members of the public that reflect a diversity of the types of accessibility issues faced by residents of our community.

Disability includes a physical, mental, intellectual, learning, or sensory impairment—including an episodic disability—that, in interaction with a barrier, hinders an individual's full and effective participation in society. FIRE SAFETY & EDUCATION

Apartment Complex Fire Safety - Know Your Building

In case of an apartment fire, be aware of:

- The locations of pull stations; activate them if there is a fire;
- Whether or not your building is monitored:
 - Yes** – When the alarm sounds, a signal will be sent to monitoring company, who will contact the fire department.
 - No** – Call 9-1-1 or 873-2222 to report a fire or alarm activation.
- Your best way out – Plan, and practice your fire escape plan.

Be fire safe in your home – know your surroundings.

Apartment Complex Fire Safety - Your Responsibilities

Apartment fire safety maintenance is the tenant's responsibility. Make sure that:

- The smoke alarm(s) in your unit are tested monthly and are in good working condition;
- Nothing is hanging from the sprinkler heads or sprinkler piping in your unit; and
- All fire doors in common hallways & stairwells stay closed. In case of fire, this is to ensure smoke doesn't block your way out.

Apartment Complex Fire Safety - Fire

During an apartment fire, take the following steps:

- Activate the pull station – if the bells are not already ringing;
- Leave the building quickly - take the stairs, not the elevator;
- Get Out quickly and Stay Out – do not re-enter the building until you are given the OK to go back in; and
- Phone 9-1-1 or 873-2222 from your meeting place if you have specifics on the fire.

Fire Safety is up to you – protect yourself.
