# **2025 INTERIM TAX PAYMENT DUE**

The City of Yellowknife reminds property owners and ratepayers that the 2025 Interim Tax Levy payment must be received by the City no later than **4:30 p.m. on Monday, March 31, 2025**.

Residents can make their Interim Tax Levy payment through their bank, in-person at City Hall by cheque or debit card, or by mailing or dropping off a cheque at the City Hall drop box.

Accounts that are not paid by the due date will be charged 1.8% interest per month until the taxes are paid in full. For more information on property tax payments and pre-authorized installments, please visit <u>www.yellowknife.ca/taxpayments</u> or call the City at (867) 920-5600.

### TOURIST ACCOMMODATION TAX COMES INTO EFFECT ON APRIL 1, 2025

The Tourist Accommodation Tax By-Law No. 5099, passed by the Yellowknife City Council in 2024, comes into effect on **April 1, 2025**. This By-law requires a 4% tax on the cost of tourist accommodation in the City. The funds will support the growth and enhancement of Yellowknife's tourism sector.

All operators of licensed tourist accommodation within Yellowknife must comply with this new tax. This includes both larger commercial properties and short-term rental hosts. Accommodation operators must report and remit the tax quarterly, with the first deadline on **July 30, 2025**. Payments can be made online through a new portal on the City of Yellowknife website that will launch prior to the first remittance date. Certain exemptions apply, including long stays (over 30 days) and specific government-related stays. For further details, visit the City of Yellowknife's website at <u>www.yellowknife.ca</u>

- School Draw Avenue from Copper Sky Condo to House 4301; and
- All of Lyons Point and Findlay Point.

#### Friday, March 21, 2025

- Wiley Road from McMeekan Causeway to Franklin Avenue; and
- 47 Street and 48 Street from School Draw Avenue to House 5508.

Residents must ensure parked vehicles are removed from these streets by midnight, or they will be towed. Residents are advised that traffic delays may occur in snow removal areas. If possible, please use an alternate route to avoid delays. The City asks residents to ensure Curbside Carts are returned to their property before the scheduled snow removal on their street. Thank you for your patience; please use caution in snow removal areas and avoid passing moving equipment.

#### **Downtown Alleys**

The City of Yellowknife will be performing snow removal in downtown alleys between 43 and 54 Street, and from 49 to 52 Avenue, during the week of **March 17 to 21, 2025**. Snow removal will begin at **3:00 a.m.** 

No signage will be posted in advance of snow removal, however, the City website will be updated for your reference. Please have vehicles and garbage receptacles removed from these areas. The City thanks you for your patience, reminds residents to use caution in snow removal areas, and not to pass moving equipment.
