#### 2022 PROPERTY ASSESSMENTS

Property Assessment Notices have been mailed out to all ratepayers (persons or businesses responsible for paying property taxes). An assessment is a value placed on property (land and buildings) for municipal and school tax purposes. Assessed values provide a means of distributing taxes among ratepayers in Yellowknife.

Compare your assessment with other similar properties in your neighbourhood using our online tool, <u>CityExplorer</u>. For land comparisons, ensure similarity of location, lot size and zoning. For building comparisons, ensure similarity of age, quality, style and size.

Please consult the "2022 A Guide to Property Taxes" posted at the City's website at <a href="www.yellowknife.ca">www.yellowknife.ca</a> for information regarding school support declarations and how to file an appeal of your assessment with the Board of Revision. Appeals may only be filed against the assessment values of your property, not the amount of taxes collected. You may call 920-5664 or 920-5625 to make appointment with the Assessor or speak with someone about your assessment.

## **SENIOR & DISABLED PERSONS TAX RELIEF**

The City would like to advise ratepayers who are currently receiving senior and/or disabled grants that the process for distributing this grant has changed. The annual grant amount remains at a maximum of \$2,000, however starting in 2022 the eligible amount will be split equally between the Interim Tax Notice in January and the Final Tax Notice in June. Previously the full amount was applied to the Interim Tax Notice.

How will this change affect you? The Interim Tax Notice will have half the grant credited, therefore, there may be a balance owing due for payment by the March 31, 2022 deadline. The Final Tax Notice will also have half the grant credited and payment of the remaining balance will be due on August 31, 2022.

Any Senior or Disabled person who has setup their property tax account with the monthly Tax Interest-Free Pre-Authorized Payment Plan (TIPP) will have NO changes to the monthly payment amount. Therefore, no action is required by you.

## WINTER TRAFFIC SAFETY TIPS

The City of Yellowknife wants to remind drivers of a few winter driving safety requirements:

- Always clear excess snow from your vehicle and windshield.
  Excess snow can obstruct the view of the driver or fly off and land on other cars creating hazards for drivers;
- Ensure your windows are fully defrosted before driving. Driving without adequate view can result in a \$100 penalty;
- During reduced visibility, turn on your headlights! This also turns on your taillights which allows drivers to see you from behind during ice fog and snow; and
- Drive to the conditions. Snow and ice reduce traction, which means you require more stopping distance. Follow at a safe distance and reduce your speed.

Plan your ride and arrive alive, don't drink and drive!

## FIRE SAFETY & EDUCATION

#### Carbon Monoxide (CO) Safety

There is a reason that Carbon Monoxide is called the silent killer. It can build up in your home without your knowledge. Some causes are chimney liner collapse (due to ice buildup), blocked air intakes (due to ice and snow buildup), malfunctions of heating system or propane-fired equipment, or vehicle running in your garage or close to air intake.

Keep your home safe by installing CO alarms close to your bedrooms. Test them monthly and replace after 7 years.

CO Poisoning Prevention:

- Maintain your chimney, furnace, fireplace, woodstove, and propane appliances. REMOVE ICE BUILDUP.
- Run your vehicle outside, and away from air intakes.

#### Response:

If your CO alarm activates, or symptoms appear (nausea, headache, burning eyes, confusion & drowsiness), get everyone outside and call 873-2222.
