### 2022 PROPERTY ASSESSMENTS

Property Assessment Notices have been mailed out to all ratepayers (persons or businesses responsible for paying property taxes). An assessment is a value placed on property (land and buildings) for municipal and school tax purposes. Assessed values provide a means of distributing taxes among ratepayers in Yellowknife.

Compare your assessment with other similar properties in your neighbourhood using our online tool, [CityExplorer](#). For land comparisons, ensure similarity of location, lot size and zoning. For building comparisons, ensure similarity of age, quality, style and size.

Please consult the "[2022 A Guide to Property Taxes](#)" posted at the City's website at [www.yellowknife.ca](http://www.yellowknife.ca) for information regarding school support declarations and how to file an appeal of your assessment with the Board of Revision. Appeals may only be filed against the assessment values of your property, not the amount of taxes collected. You may call 920-5664 or 920-5625 to make appointment with the Assessor or speak with someone about your assessment.

#### Assessments Open House

### SENIOR GRANT ALLOCATIONS

The City would like to advise ratepayers who are currently receiving senior and/or disabled grants that the process for distributing this grant has changed. The annual grant amount remains at a maximum of \$2,000, however starting in 2022 the eligible amount will be split equally between the Interim Tax Notice in January and the Final Tax Notice in June. Previously the full amount was applied to the Interim Tax Notice.

How will this change affect you? The Interim Tax Notice will have half the grant credited, therefore, there may be a balance owing due for payment by the **March 31, 2022** deadline. The Final Tax Notice will also have half the grant credited and the payment of remaining balance will be due on **August 31, 2022**.

Any Senior or Disabled person who has setup their property tax account with the monthly Tax Interest-Free Pre-Authorized Payment Plan (TIPP) will have NO changes to the monthly payment amount. Therefore, no action is required by you.

### CITY FACILITIES CLOSED FOLLOWING RECOMMENDATIONS FROM THE OCPHO

Pursuant to the Temporary Suspension of the Northwest Territories Covid-19 Gatherings Order issued by the Chief Public Health Officer, the City of Yellowknife closed the following City facilities to the public:

- City Hall;
- Fieldhouse;
- Library;
- Ruth Inch Memorial Pool;
- Multiplex; and
- Yellowknife Community Arena.

These measures will be effective until **11:59 p.m. on January 21, 2022**, or until directed otherwise by the OCPHO.

The Yellowknife Public Transit Route B Express Bus will be running at 8:00 a.m. only, with the afternoon runs being suspended. Full Express service will resume when schools reopen as directed by the OCPHO.

The City encourages residents to take advantage of the City's Virtual City Hall and eServices to make payments, and to use library cards to access the YPL's e-books and Lynda Library resources when possible.

## SNOW REMOVAL SCHEDULE

### Monday, January 17, 2022

- Franklin Avenue from Taylor Road to Forrest Drive; and
- Franklin Avenue from Norseman Drive to Taylor Road.

### Tuesday, January 18, 2022

- Old Airport Road from Range Lake Road to Borden Drive; and
- Old Airport Road from Borden Drive to Range Lake Road.

### Wednesday, January 19, 2022

- Range Lake Road from Hospital to Finlayson Drive.

### Thursday, January 20, 2022

- Hearne Hill Road from McMeekan Causeway to Otto Drive; and
- Morrison Drive from Otto Drive South to McMeekan Causeway; and
- Borden Drive from Old Airport Road to Rivett Crescent.

### Friday, January 21, 2022

- Old Airport Road from Borden Drive to Coop; and
- Old Airport Road from Coop to Borden Drive.

Snow removal begins at **12:00 a.m.** and takes place during the early morning to avoid conflicts with motorists, pedestrians and children at play. Residents must ensure parked vehicles are removed from these streets by midnight, or they will be towed. Residents are advised that there will be traffic delays in snow removal areas and if possible, to use an alternate route to avoid delays.

The City asks residents to ensure Curbside Carts are returned to their property before the scheduled snow removal on their street. Thank you for your patience, and remember to use caution in snow removal areas and not to pass moving equipment.

## SNOWMOBILE SAFETY

With many Yellowknifers out on snowmobiles this season the City reminds everyone to keep these safety tips in mind:

- There are speed limits for snowmobiles - learn and follow them;
- Always drive at a speed that will let you stop safely;
- Be mindful of, and slow down for, other trail users such as hikers, skiers, skaters and dogsleds;
- Valid snowmobile registration and insurance is required when operating in City Limits;
- Helmets are mandatory for all snowmobile riders and operators; and,
- Remember to dress appropriately and let someone know where you're going and when you expect to return.

### Chimney Ice Buildup

Look Up! How does your chimney look? Is there a build-up of ice? Remove the ice buildup on your chimney to ensure it doesn't collapse the chimney liner. With temperatures of -30 and colder, ice builds up quickly. If your chimney liner is damaged, carbon monoxide will invade your home.

Be proactive:

- Remove the ice before it builds up on your chimney;
- Install a carbon monoxide (CO) detector close to your bedrooms; and
- When you have your furnace or boiler serviced, have them check your chimney liner to ensure there is no damage.
