

**CITY OF YELLOWKNIFE
BY-LAW NO. 4316**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife authorizing the City of Yellowknife to dispose of a freehold interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT to Sections 54 of the *Cities, Towns and Villages Act*, R.S.N.W.T., 2003, c. C-22;

AND WHEREAS the said parcel(s) of land is not required for municipal purposes;

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That the Municipal Corporation of the City of Yellowknife is hereby authorized to dispose of its freehold interest in the following parcels initially by ballot draw and if necessary the remaining parcels will be placed on the open market:

LOT 35
BLOCK 304
PLAN 3862
YELLOWKNIFE; AND

LOTS 37 AND 38
BLOCK 308
PLAN 3861
YELLOWKNIFE

As outlined on Schedule "A", attached to and forming part of this By-law.

2. THAT the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT


3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.



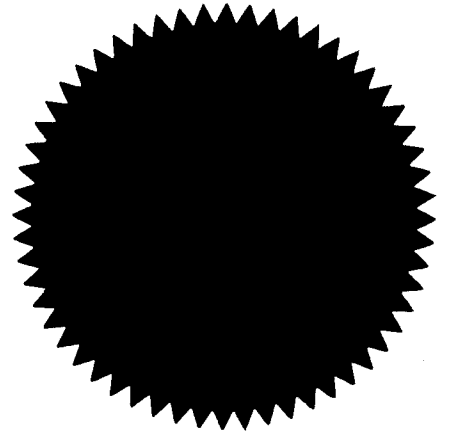

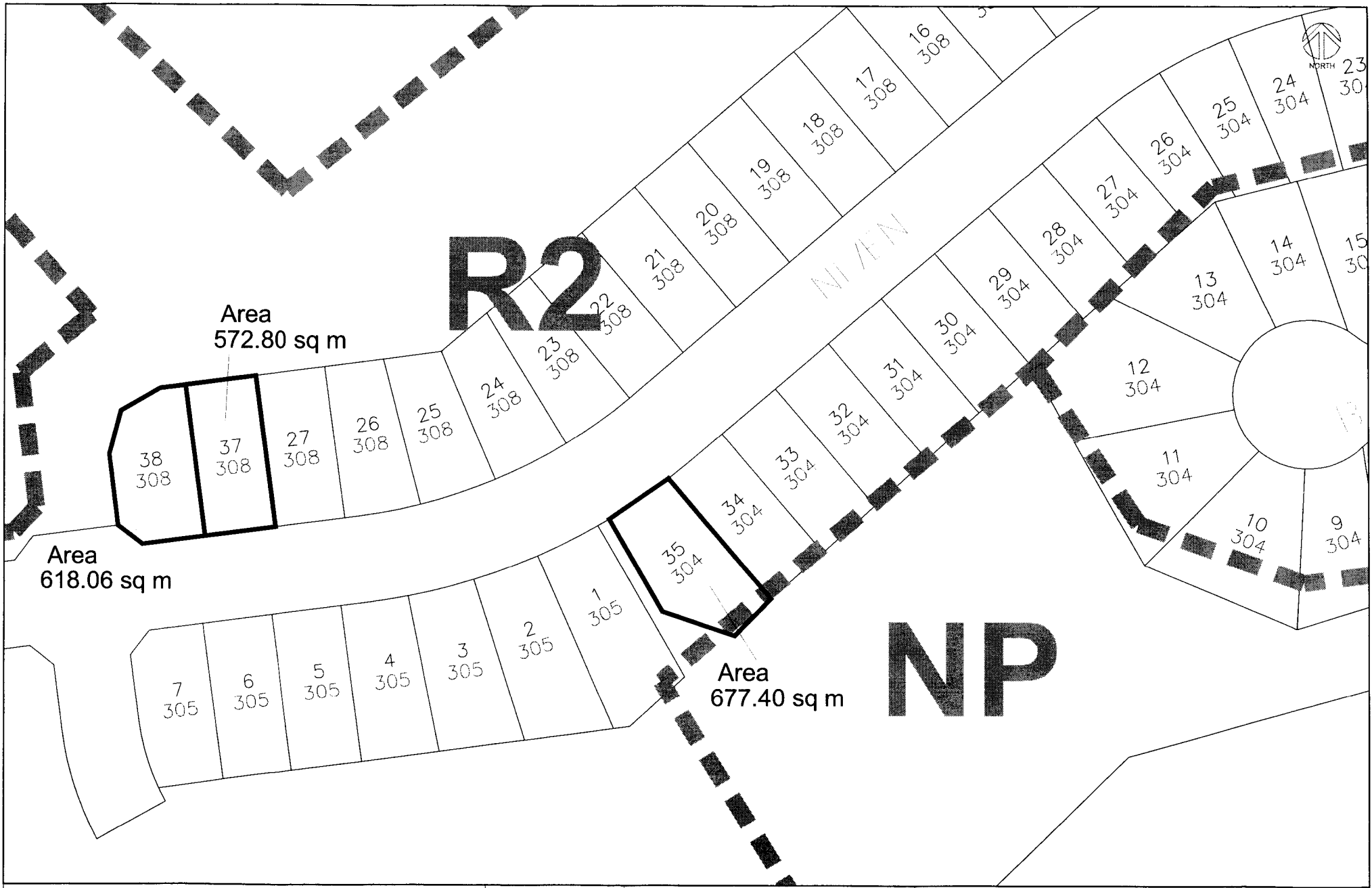
