A BY-LAW of the Municipal Council of the Corporation of the City of Yellowknife in the Northwest Territories, to amend the Yellowknife General Plan, being By-law No. 3213, as amended to date.


PURSUANT TO:

- a) Section 25 to 29 inclusive of the Planning Act, R.S.N.W.T. 1974, C. P-8.
- b) Due notice to the public, provision for inspection of the by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF YELLOWKNIFE, in a regular meeting duly assembled, enacts as follows:

1. That Lot 940, Group 964 and a portion of unsurveyed Commissioner's Land adjacent to Yellowknife Bay as outlined on Sketch No. 89-0013 attached hereto and forming part of the by-law be re-designated from "Open Space" to "Existing Residential".
2. That the Residential Map, being Map No. 3, and the Open Space, Parks, Recreation and Trails Map, being Map No. 5, shall be amended to reflect the changes enacted by this by-law according to the said attached sketch.
3. That this by-law shall come into effect upon receiving Third Reading.
