

CITY OF YELLOWKNIFE

BY-LAW NO. 3736

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, authorizing the Municipal Corporation of the City of Yellowknife to amend the City of Yellowknife General Plan 1988 By-law No. 3213, as amended to date,

PURSUANT TO:

- a) Section 25 to 29 inclusive of the Planning Act, R.S. N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted the General Plan 1988 By-law No. 3213,

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in a regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That By-law No. 3213 of the Municipal Corporation of the City of Yellowknife is hereby amended by:
 - a. deleting from Map No. 8 the Service Commercial designation from Lots 2 and 3, all in Block 549, Plan 2058 and inserting the Residential Low Density designation therefor on Map No. 3 as shown on Sketch No. 93-009 attached to and forming part of this by-law; and
 - b. inserting on Map No. 3 the Residential Low Density designation on a portion of Lot 1, Block 549, Plan 2058 as shown on Sketch No. 93-009 attached to and forming part of this by-law.

EFFECT

2. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 58 of the Cities, Towns and Villages Act.



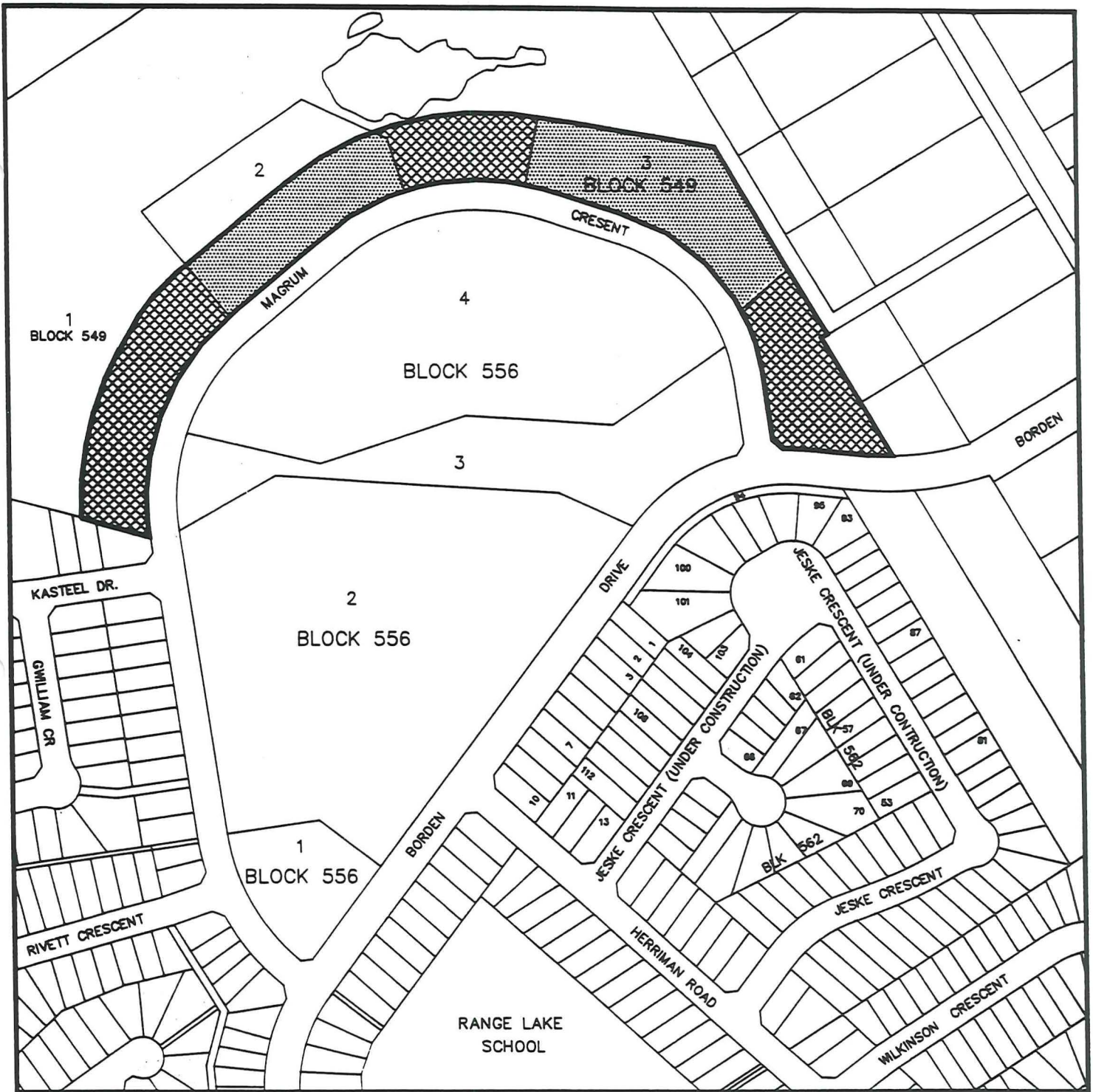

SKETCH NO. 93-009



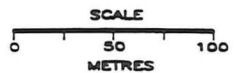
TO BE REDESIGNATED FROM
