**BY-LAW NO. 4988**

**BL 341**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife to amend By-law No. 2316, a by-law authorizing the Municipal Corporation of the City of Yellowknife to acquire leasehold interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT to Sections 53 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. 22;

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted By-law No. 2316;

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend By-law No. 2316;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

**APPLICATION**

1. That By-law No. 2316 is hereby amended by deleting Section 1 and replacing it with:

THAT the Municipal Corporation of the City of Yellowknife is hereby authorized to acquire land more particularly described as:

A parcel of unsurveyed Commissioner's Land at the west end of Grace Lake in the Northwest Territories, as shown highlighted in Schedule A, attached hereto and forming part of this by-law.

2. That the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT

3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.

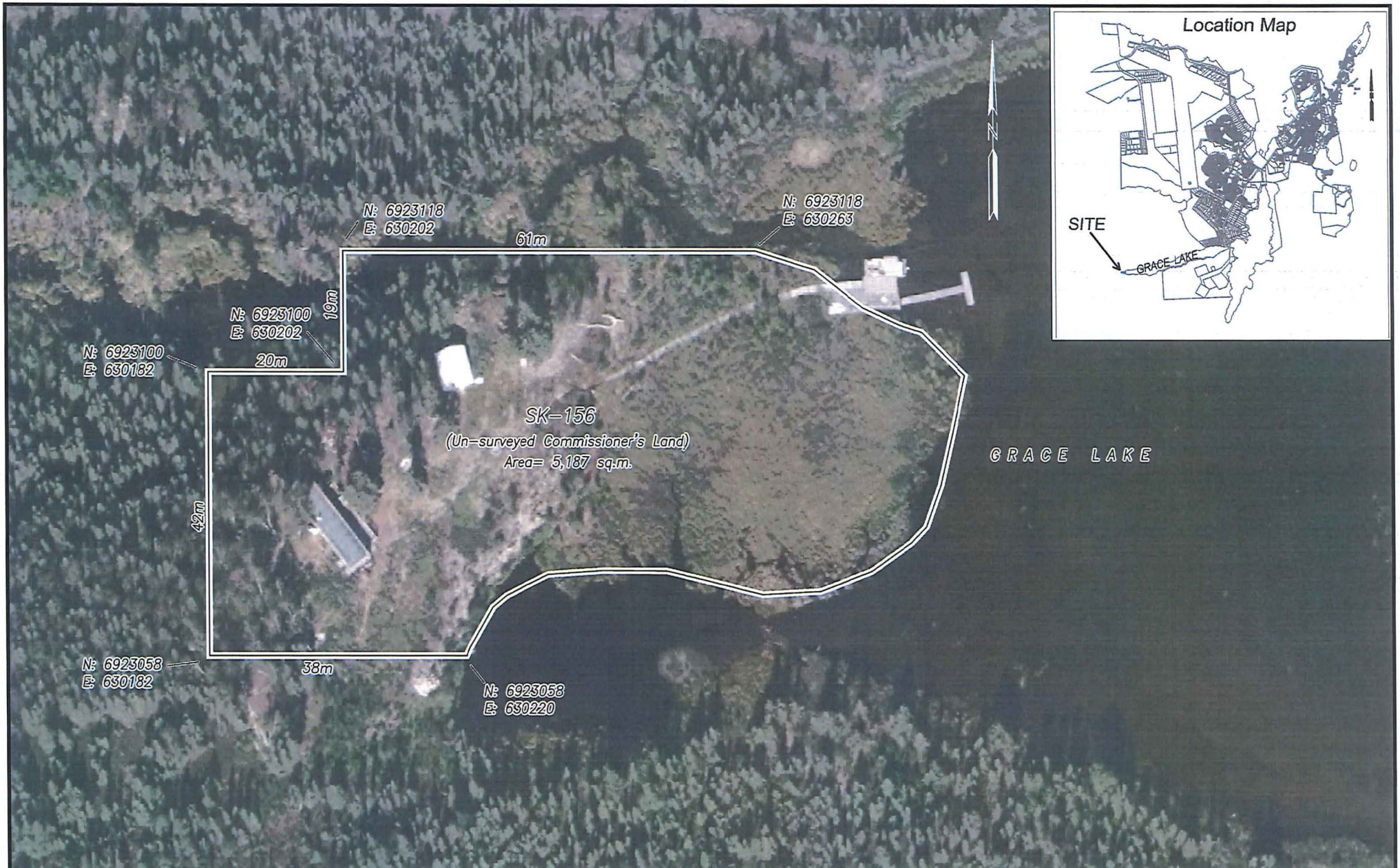
