

**CITY OF YELLOWKNIFE  
BY-LAW NO. 4689**

A by-law of the Council of the Municipal Corporation of the City of Yellowknife authorizing the Municipal Corporation of the City of Yellowknife, in the Northwest Territories, to enter into Easement Agreements.

PURSUANT to Section 54 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c.22;

WHEREAS Northland Utilities (Yellowknife) Limited is desirous of entering into Easement Agreements with the City of Yellowknife for utility easements in the Enterprise Drive Extension Subdivision (Lots 22(D) to 24(D), 26 (D) to 43 (D), Block 531; Lots 11(D), 13(D) to 21(D), Block 534; and Lots 6(D) to 11(D), 14 (D), Block 568; as shown on a Descriptive Plan of Easements reviewed by the Surveyor General under Project #201118107);

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

**APPLICATION**

1. That the Municipal Corporation of the City of Yellowknife is hereby authorized to enter into an Easement Agreement with Northland Utilities Yellowknife Ltd. for an electrical utility easement over, across and under all those portions of:

Lots 22(D) to 24(D), 26 (D) to 43 (D), Block 531;  
Lots 11(D), 13(D) to 21(D), Block 534; and  
Lots 6(D) to 11(D), 14(D), Block 568;


as shown on a Descriptive Plan of Easements reviewed by the Surveyor General under Project #201118107.

2. That the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

**EFFECT**


3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.


