

CITY OF YELLOWKNIFE
BY-LAW NO. 4539

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife, in the Northwest Territories to amend By-law No. 2955, being the Yellowknife Heritage Committee By-law.

PURSUANT TO Section 70 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c.22.

WHEREAS the Council of the Municipal Corporation of the City of Yellowknife deems it desirable to establish regulations for the operating procedures of the Yellowknife Heritage Committee.

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in the Northwest Territories, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That Heritage Committee By-law No. 2955 is hereby amended by:
 - A) Amending Section 2 by deleting (d) - "Heritage Site" in its entirety.
 - B) Amending Section 2 by adding the following subsections:
 - (e) "Designated Heritage Resource" means any Heritage Resource that is designated by a by-law of Council;
 - (f) "Heritage Resource" means a place, building, structure, or work which may be of interest because of their prehistoric, historic, cultural, natural or aesthetic value, and whether or not designated as such under the Heritage By-law;
 - (g) "Recognized Heritage Resource" means any Heritage Resource that is not designated by a by-law of Council but is acknowledged as

'Recognized' through a motion of the Heritage Committee.


- C) Deleting Sections 4(a) and (c) and replacing therewith:
 - (a) make recommendations to Council in all matters pertaining to the orderly planning, development, and management of the acquisition, designation and restoration of heritage resources.
 - (c) hear and consider representations with respect to the management of the acquisition, designation, and restoration of heritage resources.


- D) Deleting Sections 6 and 7 of Schedule A and replacing therewith:
 - 6. Copies of the Committee minutes shall be forwarded to Council through Planning and Development Department of the City of Yellowknife.
 - 7. The Planning and Development Department of the City of Yellowknife shall provide administrative support to the Committee.

EFFECT

2. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.






