

CITY OF YELLOWKNIFE

BY-LAW NO. 3792

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife authorizing the City of Yellowknife as Sublessor to sublet lands leased by the Municipal Corporation of the City of Yellowknife under Head Lease L-11387T from the Commissioner of the Northwest Territories.

PURSUANT to Section 131 of the Cities, Towns and Villages Act, R.S.N.W.T., 1988, c. C-8;

WHEREAS the Council of the Municipal Corporation of the City of Yellowknife deems it desirable and expedient to sublease land;

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

- 1. That the Municipal Corporation of the City of Yellowknife is hereby authorized to sublease a parcel of land as outlined in red on the sketch attached to and forming part of this by-law as Schedule I to Telesat Canada Inc.

THAT the Mayor and Senior Administrative Officer of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this By-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT

- 3. THIS By-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 57 of the Cities, Towns and Villages Act.

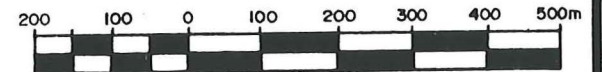
