

**CITY OF YELLOWKNIFE
BY-LAW NO. 4351**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife authorizing the City of Yellowknife to amend disposal By-law No. 4344 by replacing the legal description contained therein.

PURSUANT to Section 54 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. C-22;

AND WHEREAS the said parcel of land is not required for municipal purposes;

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. THAT By-law No. 4344, a by-law authorizing the City to dispose a freehold interest in a parcel of land, is hereby amended by deleting the legal description and replacing it with the following:

Lots 7, 8, 9 and 10, Block 80, Plan 72; and

Lot 14, Block 80, Plan 3950.

Yellowknife

2. THAT the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, agreements and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT

3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.

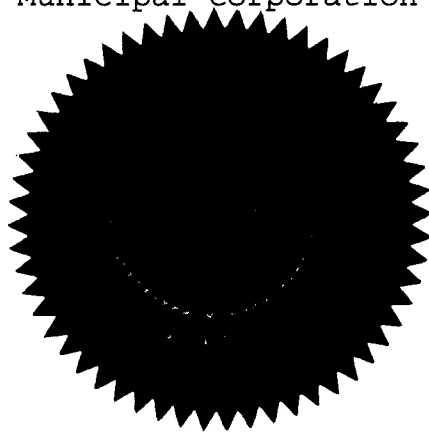

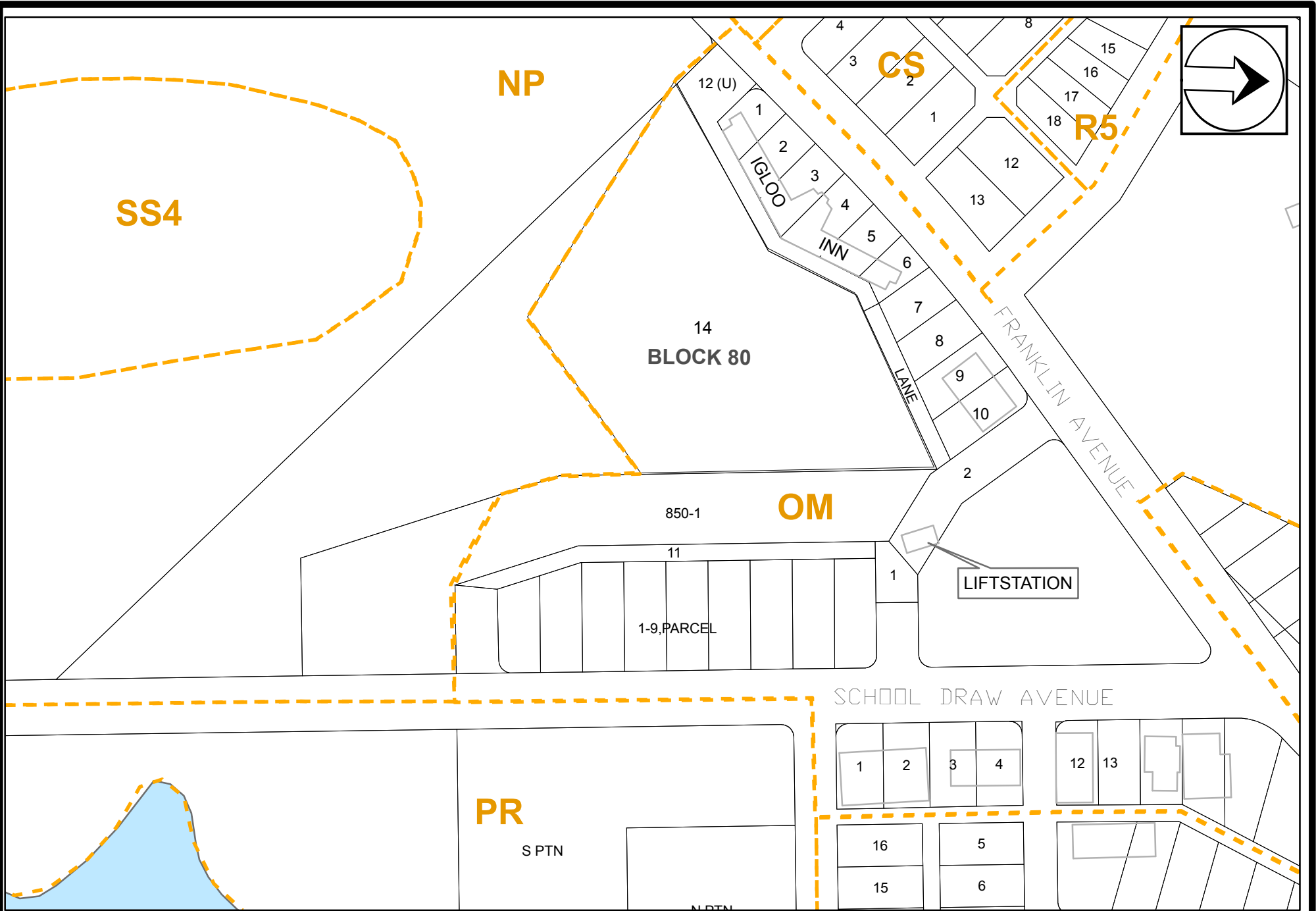
