



CITY OF YELLOWKNIFE

BY-LAW NO. 4944

BS 768

A by-law of the Council of the Municipal Corporation of the City of Yellowknife authorizing the Municipal Corporation of the City of Yellowknife to dispose of a fee simple interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT to Sections 54 and 73 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. 22;

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted By-law No. 4878;

AND WHEREAS the Municipal Corporation of the City of Yellowknife is desirous of amending By-law No. 4878;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That By-law No. 4878 is hereby amended by deleting and replacing "Lots 44 and 45, Block 311, as shown on a Plan of Survey under Surveyor General Branch Project #201618045, Yellowknife" under Application 1 with the following:

"All those portions of:

Lots 44 and 45, Block 311, as shown on a Plan of Survey under Surveyor General Branch Project #201618045, Yellowknife

Lying within:

Lot 39, Block 311, Plan 4019"

2. That the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT

3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.
