

**CITY OF YELLOWKNIFE
BY-LAW NO. 4573**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife to amend By-law No. 4292, being a by-law authorizing the City to dispose of a leasehold interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT to Sections 54 and 73 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. 22;

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted By-law No. 4292;

AND WHEREAS the Municipal Corporation of the City of Yellowknife is desirous of amending By-law No. 4292 by amending the legal descriptor provided therein;

AND WHEREAS the Municipal Corporation of the City of Yellowknife is desirous of amending By-law No. 4292 by deleting and replacing, in its entirety, Schedule A attached thereto;

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That By-law No 4292 is hereby amended as follows:

Deleting the following reference:

Unsurveyed Lands as shown outlined on Schedule A attached to and forming part of this by-law;

and replacing therewith:

All of those lands as shown outlined in red on Schedule A attached to and forming part of this by-law;

2. That Schedule A of By-law No. 4292 of the Municipal Corporation of the City of Yellowknife, be deleted and replaced with Schedule A attached hereto and forming part of this by-law.

EFFECT

3. THIS by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.
