



CITY OF YELLOWKNIFE

**BY-LAW NO. 4950**

**BA 322**

A by-law of the Council of the Municipal Corporation of the City of Yellowknife authorizing the Municipal Corporation of the City of Yellowknife to acquire, from T.C. Enterprises Ltd., a fee simple interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT to Sections 53 and 73 of the *Cities, Towns and Villages Act*, S.N.W.T., 2003, c. 22;

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted By-law No. 4420, as amended;

AND WHEREAS the Municipal Corporation of the City of Yellowknife is desirous of amending By-law No. 4420, as amended;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

**APPLICATION**

1. That By-law No. 4420, as amended is hereby amended by deleting and replacing "All that portion of Lot 3, Block 92, Plan 1769, lying within Road R32 Weledeh, as shown on a Plan of Survey reviewed by the Deputy Surveyor General North under Item No. 2006-18-055." with the following:

"All that portion of Road R32 Weledeh lying within Lot 3, Block 92, as shown on a Plan of Survey under Surveyor General Branch Project #201718007, Yellowknife."

2. That the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of application, deeds, indentures, and other documents as may be necessary to give effect to this by-law and to affix thereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

**EFFECT**

3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.
