

**CITY OF YELLOWKNIFE
BY-LAW NO. 4506**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, to authorize the Mayor and City Administrator, on behalf of the City of Yellowknife, to execute an Agreement with the International Association of Fire Fighters, to provide for the employment and conditions of employment of certain employees of the City who are members of the International Association of Fire Fighters (IAFF), Local 2890;

PURSUANT To Section 48 of the *Cities, Towns and Villages Act*, S.N.W.T. 2003, c. 22.

WHEREAS the City of Yellowknife and the International Association of Fire Fighters are desirous of entering into an Agreement with respect to the employment and conditions of employment of those employees of the City represented by the International Association of Fire Fighters Local 2890 for a term commencing January 1, 2009.

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, enacts as follows:

SHORT TITLE

1. This By-law may be cited as the "International Association of Fire Fighters, Local 2890 Collective Agreement (2009 - 2011) By-law".


AUTHORIZATION

2. The Mayor and City Administrator are hereby authorized to execute on behalf of the City of Yellowknife the Collective Agreement, referred to as Schedule "A" annexed hereto and forming part of this By-law.

EFFECT

3. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 75 of the *Cities, Towns and Villages Act*.

READ a First Time this 19TH day of DECEMBER A.D., 2008.


