

**CITY OF YELLOWKNIFE
BY-LAW NO. 4294**

A by-law of the Municipal Corporation of the City of Yellowknife in the Northwest Territories to provide for the appointment of By-law Officers;

PURSUANT to Section 171 of the *Cities, Towns and Villages Act*, R.S.N.W.T., 1988, c. C-8;

WHEREAS the Council of the Municipal Corporation of the City of Yellowknife deems it desirable to appoint By-law Officers for the enforcement of Municipal By-laws in the City of Yellowknife;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session, duly assembled, hereby enacts as follows:

SHORT TITLE

1. This by-law may be cited as the "By-law Officers By-law".
2. In this by-law:

"By-law Officer" Means a person who is appointed in accordance with the *Cities, Towns and Villages Act* as a By-law Officer to enforce the by-laws of the City of Yellowknife and any Peace Officer who is entitled by law to enforce the by-laws of the City of Yellowknife.

"City" means the Municipal Corporation of the City of Yellowknife.

"Constable" means the rank given to a By-law Officer.

APPLICATION

3. That the persons named in Schedule 1, attached to and forming part of this by-law, are hereby appointed as By-law Officers.
4. That all By-law Officers so appointed shall assume the rank of Constable.
5. That By-law Officers so appointed shall carry out the duties specified in Section 172 of the *Cities, Towns and Villages Act*, R.S.N.W.T. 1988, c.C-8.

6. That the term of appointment shall expire upon termination of employment with the City as a By-law Officer.


REPEALS

8. That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 57 of the *Cities, Towns and Villages Act*.

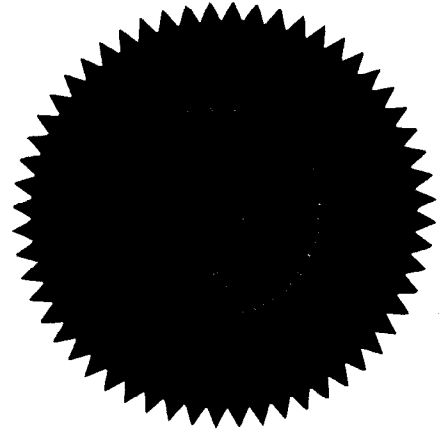
