

**CITY OF YELLOWKNIFE
BY-LAW NO. 4442**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories to amend By-law No. 4364, which establishes the Terms of Reference for the Yellowknife (2008) Arctic Winter Games Host Society, so as to expand the Executive to include one (1) additional member.

PURSUANT TO the relevant provisions of the *Cities, Towns and Villages Act*, S.N.W.T. 2003, c.22 including 73.(1), which provides that the Council of a municipality may by by-law, amend or repeal a by-law;

WHEREAS the Council of the Municipal Corporation of the City of Yellowknife adopted By-law No. 4358 on May 9, 2005, which authorized the City to enter into an Agreement with the Arctic Winter Games International Committee ("AWGIC") to host the 2008 Games and the Agreement was then entered into on May 18, 2005 by the Mayor, the Senior Administrative Officer and the President of the AWGIC;

AND WHEREAS the Council of the Municipal Corporation of the City of Yellowknife adopted By-law No. 4364, a by-law establishing the Yellowknife (2008) Arctic Winter Games Society and its Terms of Reference on June 13, 2005;

AND WHEREAS the Council of the Municipal Corporation of the City of Yellowknife wishes to amend By-law No. 4364 to expand the Executive of the Yellowknife (2008) Arctic Winter Games Host Society by adding one (1) additional member in order to allow it to better fulfill its mandate;

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular sessions duly assembled, enacts as follows:

APPLICATION

1. By-law No. 4364 is hereby amended by:

(a) Deleting section 2) a) of Schedule "A" in its entirety and replacing it with:

"a) The Officers of the Society shall be a President, First Vice President, Second Vice President, Treasurer, and Secretary."


- (b) Amending section 4) b) to state "First Vice-President" where it currently states "Vice President".
- (c) Amending section 8) b) by adding the following text after the text currently in place:

"The Second Vice-President shall assist the First Vice-President in his/her duties when called upon, and may assume the responsibilities of the President in the absence of the President and the First Vice-President."

EFFECT


- 2. This by-law shall come into effect upon having received Third Reading and otherwise meeting the requirements of Section 75 of the *Cities, Towns and Villages Act*.


