

**CITY OF YELLOWKNIFE**  
**BY-LAW NO 4286**

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, authorizing the Municipal Corporation of the City of Yellowknife to amend the City of Yellowknife General Plan By-law No. 3898, as amended.

PURSUANT TO:

- a) Section 25 to 29 inclusive of the *Planning Act*, R.S.N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted General Plan By-law No. 3898;

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend General Plan By-law No. 3898, as amended;

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in a regular session duly assembled, hereby enacts as follows:

**APPLICATION**

- 1 That By-law No 3898 of the Municipal Corporation of the City of Yellowknife, is hereby amended by
  - A) Amending Map 1 "Long Range Land Use Plan" of General Plan By-law No 3898, as amended, in accordance with Schedule No 1 attached to and forming part of this by-law

**EFFECT**


- 2 That this by-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 57 of the *Cities, Towns and Villages Act*



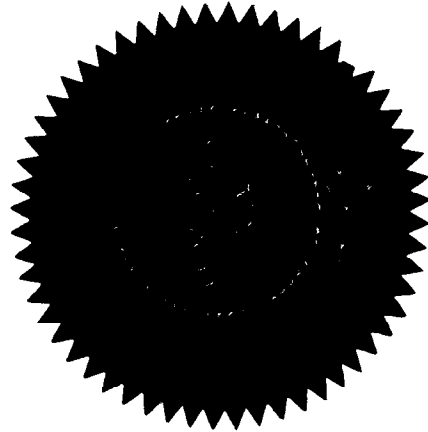

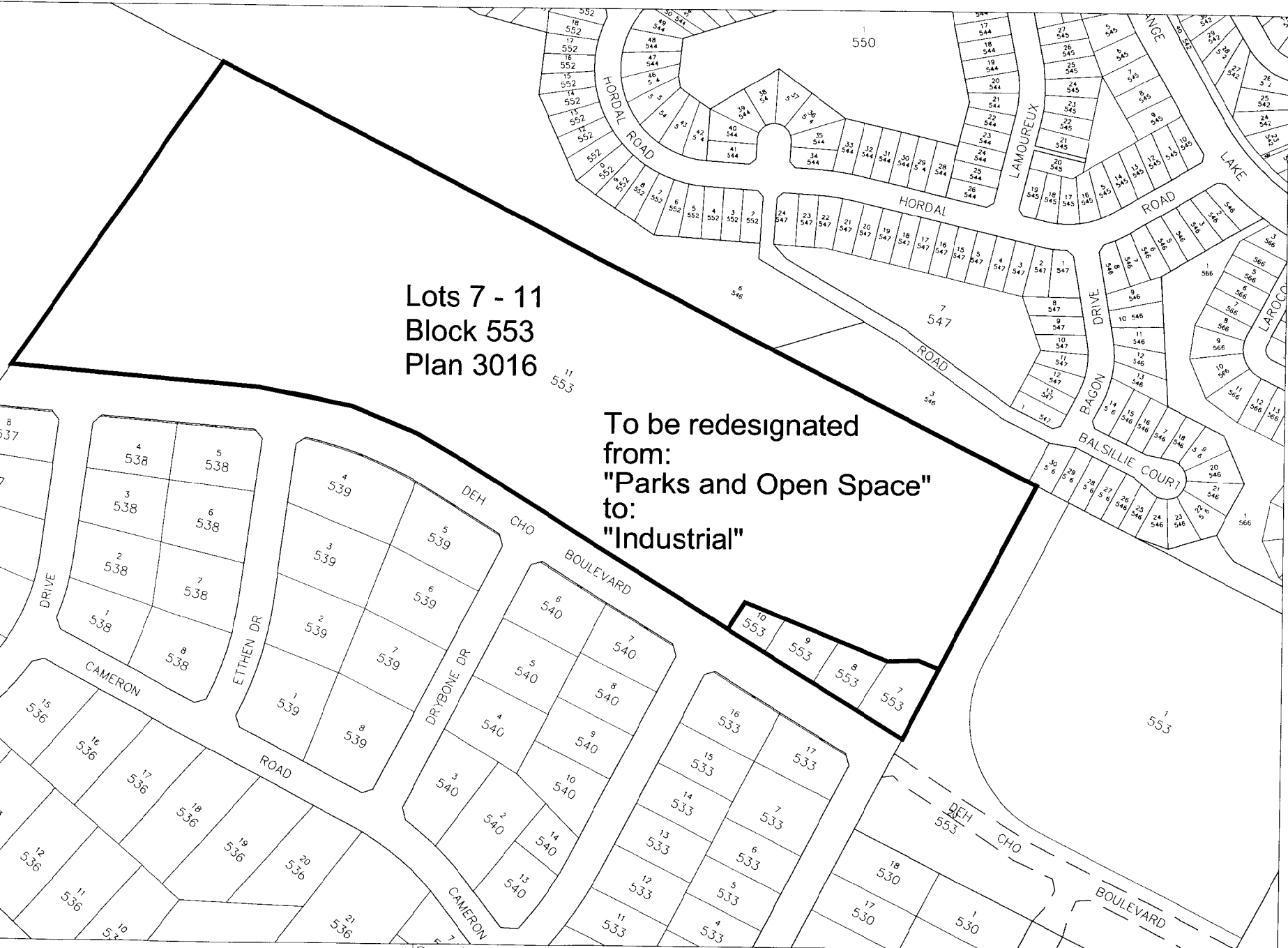
