

CITY OF YELLOWKNIFE

BY-LAW NO. 3781

A BY-LAW of the Council of the Municipal Corporation of the City of Yellowknife in the Northwest Territories, authorizing the Municipal Corporation of the City of Yellowknife to amend the City of Yellowknife General Plan 1988 By-law No. 3213, as amended to date,

PURSUANT TO:

- a) Section 25 to 29 inclusive of the Planning Act, R.S. N.W.T., 1988, c. P-7;
- b) Due notice to the public, provision for inspection of this by-law and due opportunity for objections thereto to be heard, considered and determined; and
- c) The approval of the Minister of Municipal and Community Affairs, certified hereunder.

WHEREAS the Municipal Corporation of the City of Yellowknife has enacted the General Plan 1988 By-law No. 3213,

AND WHEREAS the Municipal Corporation of the City of Yellowknife wishes to amend the General Plan 1988 By-law No. 3213, as amended to date,

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in a regular session duly assembled, hereby enacts as follows:

**APPLICATION**

- 1. That By-law No. 3213 of the Municipal Corporation of the City of Yellowknife is hereby amended by:
  - a. deleting from Map No. 7 the Local Commercial designation from Lot 75, Block 519, Plan 1890 and inserting therefor the Medium - High Density designation on Map 3 as shown on Sketch No. 93-0010 attached to and forming part of this by-law.


**EFFECT**



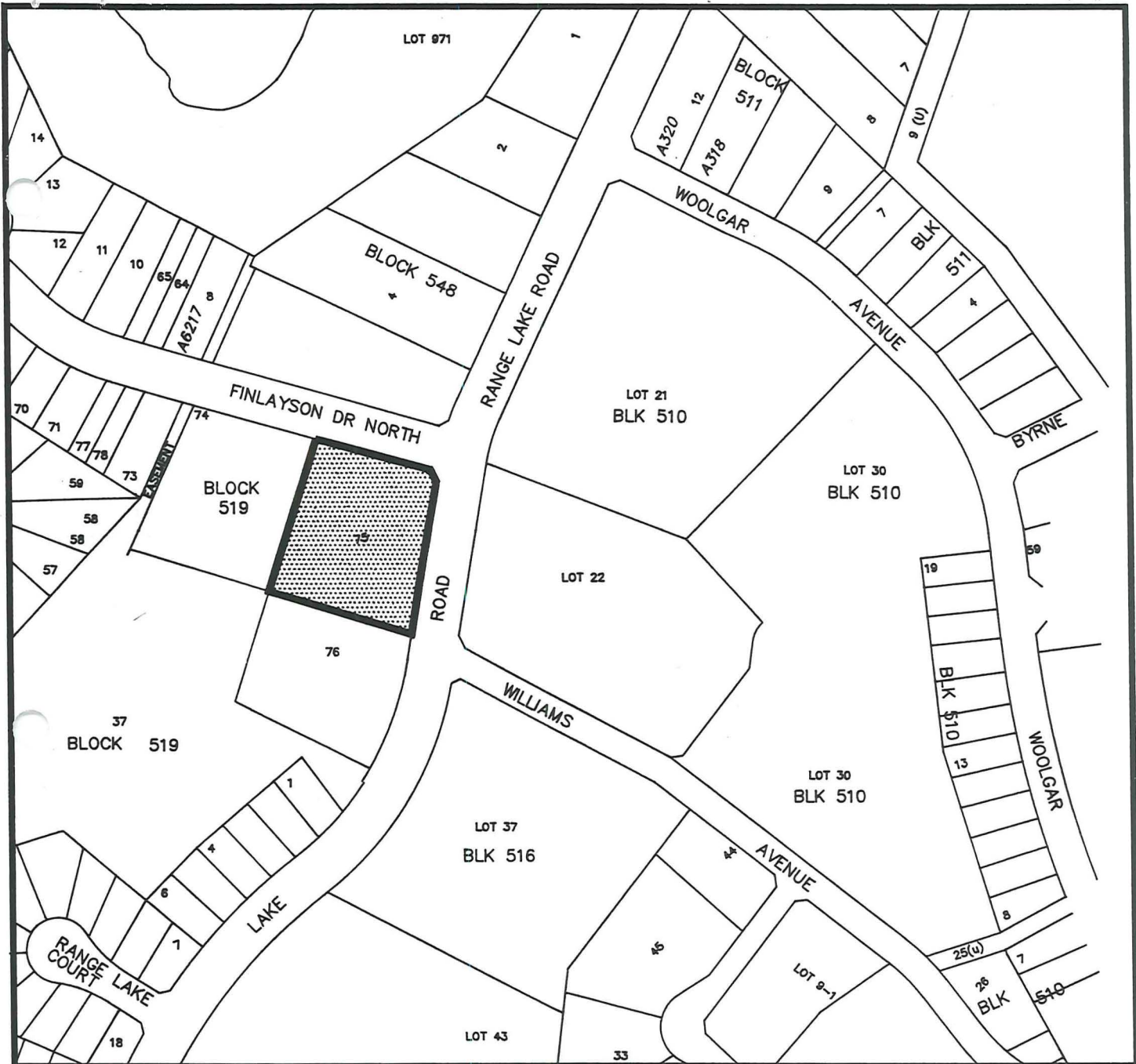
