

**CITY OF YELLOWKNIFE
BY-LAW NO. 4304**

A By-law of the Council of the Municipal Corporation of the City of Yellowknife authorizing the City of Yellowknife to acquire an interest in land for the Municipal Corporation of the City of Yellowknife, in the Northwest Territories.

PURSUANT TO Section 132.1 of the *Cities, towns and Villages Act*, R.S.N.W.T., 1988, c. C-8;

WHEREAS the said parcel of land is available for acquisition by the Municipal Corporation of the City of Yellowknife;

AND WHEREAS the said parcel of land is required for Municipal purposes,

NOW THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF YELLOWKNIFE, in regular session duly assembled, hereby enacts as follows:

APPLICATION

1. That the Municipal Corporation of the City of Yellowknife is hereby authorized to acquire a leasehold interest in a parcel of land more particularly described as:

All that parcel of land, as outlined on Schedule A, attached to and forming part of this By-law.

2. That the Mayor and City Administrator of the Municipal Corporation of the City of Yellowknife, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the Municipal Corporation of the City of Yellowknife, to execute all such forms of agreements, applications, deeds, indentures, and other documents as may be necessary to give effect of this By-law and to fix hereto the corporate seal of the Municipal Corporation of the City of Yellowknife as the act and deed thereof, subscribing their names in attestation of such execution.

EFFECT

3. That this By-law shall come into effect upon receiving Third Reading and otherwise meets the requirements of Section 57 of the *Cities, Towns and Villages Act*.

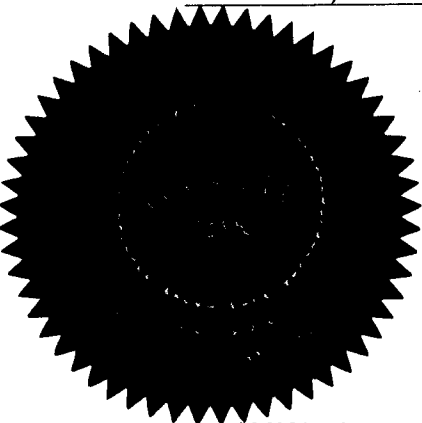

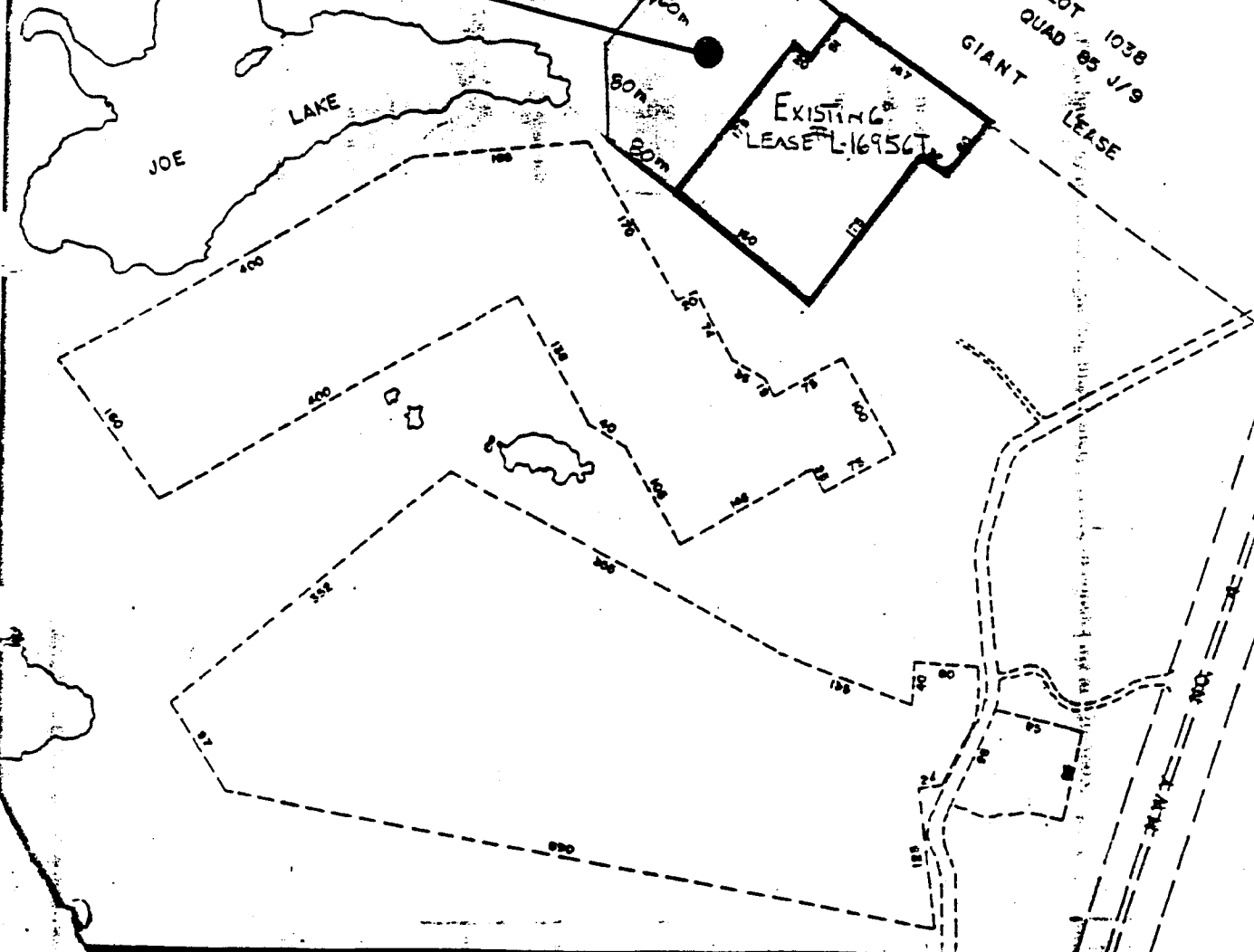
